 - i. Academic/Curriculum Overview Quest for Success at Franklin; Discussed iReady diagnostic Franklin versus average FA is outperforming Florida and national schools for reading (K-8). HS only intensive reading diagnostic; School District uses iReady too. Similar in math, not outperforming in every grade but we are catching up those students. Increases in performance from initial testing. IB updates awaiting BB and PBG approval letters by next 4 weeks. Addressed matters to be addressed. CC is up to re-authorization. Between Jan and March 2021. Unit plans have

already been submitted. Jeans drive – Diploma Programme sought 10k grant; 2500 for college to organizers.

i. Organizational Overview/Update – building purchases – closed on Jan 30 on purchase of PBG and PPK12 – approx. 90MM purchase price – collaborative effort of foundation and campuses; Grant received – garbage compactors at SUN and PPK12 - \$36k per campus. Going in this summer. Coronavirus update – fast moving – posting on website – updates and links Ask governing board to take up a resolution on coronavirus to authorize Foundation team under Dr. Thomas' guidance to put together a business continuity plan and structure for communication and authorize us to act upon plan if necessary. State budget – lawmakers need more time to approve budget – determines our funding – 2-3 days; Enrollment – first window close 2/28; next one 3/19. 4,700 applications across organization – slightly off pace – more competition which is not surprising because districts doing better – lottery at all 6 campuses; Marketing – new television commercial in Palm Beach – running now 52 extra spots during march madness basketball games

j. Mr. Richard Moreno, Financial Consultant

Financial Review – Acquire 2 buildings – 662M order for bonds – oversubscribed. Updated budgets for PBG and PPK12 – loss instead of gains.
Still operating very tight. Other budgets are tracking in line. Teacher pay increase and how it gets implemented will be discussed once we know

approved budget. Will be able to build reserves now. Working on gymnasium issue.

- VII. Resolutions Dr. Thomas speaks on coronavirus opines it probably will become a world-wide epidemic the more cases we see, the more the death rate will go down. Everyone who has died has had multiple conditions and in many cases are aged. Dr. Thomas feels media is being irresponsible. Serious yes, but it should not cause a panic. Do need to address Dr. Thomas takes up resolution to authorize Foundation team, specifically Scott Sznitken, Deborah Hanley and Dr. Sandberg to work with guidance of Dr. Thomas to create and potentially implement business continuity plan and school closing plan. Board Member Orshefsky makes the motions; Board Member Greenberg seconds the motion. There are no objections. All in Favor. The motion passes.
